Math 2418 Linear algebra or equivalent. Undergraduate quantum mechanics is recommended, but not required

Course Description:

Provides an introduction to the theory and practice of quantum computation.

Topics covered:

Physics of information processing; quantum logic; quantum algorithms including Shor's factoring algorithm; quantum communications; quantum error corrections; quantum hardware.

<u>Additional requirement for graduate students</u>: An independent research project under the instructor's supervision.

Learning Outcomes:

The undergraduate student in the class will learn the foundation of quantum computation and quantum communications as well as certain practical applications. They will develop basic problem solving ability for fundamental issues as well concrete examples. The study will help them in the future work and research, either in industry or academy.

<u>Difference Outcomes for graduate students</u>: In addition to the above learning outcomes at undergraduate level, the graduate student will learn how to perform scientific research in the field of quantum information science, which involves literature reading, topic selection, concrete calculation, oral presentation and scientific writing.

Assignments & Academic Calendar

Homework problems will be assigned from textbooks and additional sources. Homework normally is to be turned in at the start of class on Monday. Exceptions will be clearly posted with the assignment. Your work should be neat, problems should be ordered, and pages should be stapled.

Students may work on homework with classmates, but each student is required to write up his/her answers independently. Outright copying is not permitted. You are required to write all collaborating group members' names at the start of the problem. Failure to disclose all members of a collaborating homework group will be treated as plagiarism. I recognize that some students will master this material better by working in peer groups, however I reserve the right to restrict homework collaboration at my discretion. If you need additional help, you should be discussing the problem with the course TA or the instructor, and not consulting a solution key from the publisher or any other source.

Grading Policy

Individual Homework problems are usually given equal weight and are graded on a 10 point scale. Homework will count towards 30% of the course grade. Exams will count for 50% of the course grade. There will a midterm exam and a final exam, each carrying equal weight. The research project will count 20% toward the final grade.

Withdrawal from Class

The administration of this institution has set deadlines for withdrawal of any college-level courses. These dates and times are published in that semester's course catalog. Administration procedures must be followed. It is the student's responsibility to handle withdrawal requirements from any class. In other words, I cannot drop or withdraw any student. You must do the proper paperwork to ensure that you will not receive a final grade of "F" in a course if you choose not to attend the class once you are enrolled.

Student Grievance Procedures

Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's *Handbook of Operating Procedures*.

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the deal will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.

Copies of these rules and regulations are available to students in the Office of the Dean of Students, where staff members are available to assist students in interpreting the rules and regulations.

Incomplete Grade Policy

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of **F**.

Essentially, the law requires that colleges and universities make those reasonable adjustments necessary to eliminate discrimination on the basis of disability. For example, it may be necessary to remove classroom prohibitions against tape recorders or animals (in the case of dog guides) for students who are blind. Occasionally an assignment requirement may be substituted (for example, a research paper versus an oral presentation for a student who is hearing impaired). Classes enrolled students with mobility impairments may have to be rescheduled in accessible facilities.

The college or university may need to provide special services such as registration, note-taking, or mobility assistance. It is the student's responsibility to notify his or her professors of the need for such an accommodation. Disability Services provides students with letters to present to faculty members to verify that the student has a disability and needs accommodations. Individuals requiring special accommodation should contact the professor after class or during office hours.

Religious Holy Days

The University of Texas at Dallas will excuse a student from class or other required activities for the travel to and observance of a religious holy day for a religion whose places of worship are exempt from property tax under Section 11.20, Tax Code, Texas Code Annotated.

The student is encouraged to notify the instructor or activity sponsor as soon as possible regarding the absence, preferably in advance of the assignment. The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence: a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
